

EVENT STAFF INDEPENDENT CONTRACTOR AGREEMENT 2023 - 2024

This Independent Contractor Agreement (this "Agreement") is made as of this ____ (day) of _____ (month), 20____ (year), (the "Effective Date") by and between CELEBRITY CHEER & DANCE CHAMPIONSHIPS, LLC located at 816 W Elgin Broken Arrow, OK 74012, ROCKSTAR CHAMPIONSHIPS, LLC located at 12601 Cottontail Road, Yukon, OK 73099 and REVOLUTION CHAMPIONSHIPS, LLC located at 1312 NW 189th St., Edmond, OK 73012

("EVENT STAFF"). CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS and EVENT STAFF may each be referred to in this Agreement as a "Party" and collectively as the "Parties."

1. Services. EVENT STAFF shall provide the following services to CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS (the "Services"): Serves as support labor for CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS (the "Services"); EVENT STAFF shall perform such other duties and tasks, or changes to the Services, as may be agreed upon by the Parties.

2. Compensation. EVENT STAFF shall be compensated by the CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS for services rendered. In consideration for EVENT STAFF's performance of the Services, CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS shall pay EVENT STAFF via direct deposit at the end of each assigned event.

CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS will not withhold any sums from payments made to EVENT STAFF for social security, unemployment, workers' compensation or other federal, state, or local tax liabilities or contributions, and all such necessary withholdings, liabilities, and contributions shall be solely the responsibility of EVENT STAFF.

3. Expenses. CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS shall pre-pay or reimburse EVENT STAFF for all pre-approved, reasonable, and necessary costs and expenses incurred in connection with the performance of the Services.

4. Term and Termination. EVENT STAFF's engagement with CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS under this Agreement shall commence on November 1, 2023 - May 31, 2024. At the time of termination, EVENT STAFF agreed to return all CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS property used in performance of the Services, including but not limited to reports and other equipment and documents.

5. Independent Contractor. The Parties agree and acknowledge that EVENT STAFF is an independent contractor and is not, for any purpose, an employee of CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS.

6. Confidentiality: a. Confidential and Proprietary Information. While performing the Services, EVENT STAFF will be exposed to confidential and proprietary information of CELEBRITY, ROCKSTAR, AND REVOLUTION CHAMPIONSHIPS. "Confidential Information" shall mean any data or information that is competitively sensitive material and not generally known to the public, including, but not

limited to, information relating to development and plans, marketing strategies, finance, operations, systems, and proprietary concepts.

b. Confidentiality Obligations. Except as otherwise expressly permitted in this Agreement, EVENT STAFF shall not disclose or use in any manner, directly or indirectly, any Confidential Information either during the term of this Agreement or at any time thereafter,

7. Governing Law. The terms of this Agreement and the rights of the Parties hereto shall be governed exclusively by the laws of the State of Oklahoma, without regarding its conflicts of law provisions.


