Before you submit a form, please review the following tips!

- Review the video to determine if you see what the judge commented about on your score sheet.
- Pull up the rules document so and read the specific rule cited so that you are aware of the legality being given. The glossary is a helpful tool at the beginning of the rules document.
- Did you confirm that all of your athletes executed the skills that were choreographed in the routine? Credit is given for skills executed. If the skill is attempted and missed, it does not count towards difficulty scores
- Is it a reviewable scoring category?
 - Stunt Baseline
 - Coed Stunt Baseline
 - Pyramid Baseline Score
 - Miscalculation 'Did Not Perform' marked and additional technique drivers marked.

- Toss Difficulty Score
- Toss Tech Score
 - Only if 0.6 is marked and you performed more than one toss in routine

- Jump Difficulty Score
- Tumbling Baseline Scores
- Tumbling Variety Baseline Score
- Deductions
- Legality

CHAMPIONSHIP OR SWICHAMPIONSHIP FEBRUARY

If the Score is Incorrect:

- The Score Review Specialist will not call you back to the score review booth.
- The score will be updated, and a new scoresheet will be sent to you.
- You will receive a text notification to check your email for your updated score.

If the Score is Correct:

 The Score Review Specialist will discuss the reasons for the score's accuracy in a score review booth.

Previous Event Scores:


Scores from previous events will not be discussed in the score review.

Texting Communication:

The number used for texting is not monitored. It's part of our online system for processing score reviews. Any text sent to that number or any of the phones of our review specialists will not be answered.

Allstar World Championship Core Review Process

The following steps are how score review will take place at ASWC.





Allstar World Championship Score Review Process



Coaches will be able to have 20 minutes from the time the scoresheets are sent to complete a score review form.

A Score Review Specialist will review the routine and there will be a time limit of 5 minutes that a coach can discuss the ruling with the official at the event. Coaches that refuse to leave the score review area after the 5 minute time limit will result in their team having an unsportsmanlike deduction of .25

Coaches are expected to conduct themselves in a professional manner. No yelling, use of swear/curse words, or arguing will be tolerated. The score review area is designed for professional conversations to occur at an event. It is not the time or place for coaches to be trained on the score sheet. The Open Championship Series hosts monthly webinars on scoring and provides links to submit skills for review throughout the season for coaches educational opportunities.

The decision of the Score Review Specialist is FINAL!



FAQS ABOUT SCORE REVIEW AT ASWC



CAN I JUST HAVE A SCORE REVIEW SPECIALIST SHOW ME MY DEDUCTIONS?

DUE TO THE VOLUME OF TEAMS AT THIS EVENT, WE ASK THAT YOU WATCH THE DECUTION ON THE COMPUTERS BEFORE FILLING OUT A FORM TO WATCH THE DECUCTION WITH A SCORE REVIEW SPECIALIST.

WHY DO I ONLY HAVE 5 MINUTES WITH A SCORE REVIEW SPECIALIST?

WITH A ROUTINE ONLY LASTING 2:30, IT SHOULD NOT TAKE LONGER THAN 5 MINTUES TO EXPLAIN THE RULING ON A SKILL OR A LEGALITY THAT IS CALLED. THE REVIEW SPECIALIST WILL HAVE REVIEWED THE VIDEO OF YOUR ROUTINE BEFORE TALKING TO YOU IN THE REVIEW AREA, THEFORE THE EXPLINATION SHOULD NOT TAKE MORE THAN 5 MINUTES. WITH THE VOLUME OF QUESTIONS FROM CUSTOMERS, IT IS IMPORTANT THAT WE MOVE QUICKLY TO MAKE SURE COACHES ARE NOT WAITING FOR LONG PERIODS OF TIME TO TALK TO A SCORE REVIEW SPECIALIST.

WHAT HAPPENS IF I HAVE RECEIVED CREDIT FOR SOMETHING ALL SEASON, AND THEN I DO NOT RECIEVE CREDIT FOR IT AT ASWC?

WE HAVE HOSTED MONTHLY SCORING CALLS AND OUR DOCUMENTS ARE CLEAR ON WHAT IS CONSIDERED ELITE CREDIT FOR OUR EVENTS. IF YOU HAD MISTAKENLY RECIEVED ELITE CREDIT AT A QUALIFYING EVENT, THAT IS NOT TAKEN INTO CONSIDERATION FOR THIS EVENT. THE ROUTINES AT THIS EVENT WILL BE SCORED ON THE SKILLS EXECUTED BY THE TEAMS ON THE DAY THEY COMPETE AT THIS EVENT.

WHAT HAPPENS IF I GET CALLED ON A LEGALITY THAT I HAVE NEVER BEEN CALLED ON THIS SEASON? WHAT IF IT IS ON DAY 2 OF THIS EVENT?

OUR LEGALITY JUDGES AT THIS EVENT ARE CALLING THE SKILLS AS THEY SEE THEM. IT IS THE COACHES RESPONSIBLITY TO KNOW THE RULES AND TO SEND IN VIDEOS OF THE SKILLS TO THE PLATFORM THAT WE HAVE FOR APPROVING PROPS, STUNTS, PYRAMIDS, TOSSES, AND TUMBLING SKILLS. JUDGES ARE HUMAN. IF SOMETHING IS MISSED ON DAY 1 AND SEEN ON DAY 2, IT WILL BE GIVEN A PENALTY ON DAY 2. EACH DAY OPERATES AS ITS OWN EVENT. SCORING DOES NOT CARRY OVER, SO THE LEGALITY WILL BE ASSED ON THE DAY IT IS SEEN FROM THE JUDGE



FAQS ABOUT SCORE REVIEW AT ASWC



WHAT IF I WANT TO DISCUSS A SCORE THAT IS NOT ON THE LIST OF SCORES THAT CAN BE CHALLENGED?

YOU ARE WELCOME TO FILL OUT A FORM TO LET US KNOW ABOUT THE DISAGREEMENT OF THE SUBJECTIVE SCORES. THESE WILL NOT BE LOOKED AT WHILE WE ARE AT THE EVENT. SUBJECTIVE SCORES ARE PART OF OUR SPORT AND OUR SCORESHEET. IT IS THE EXPERT THAT IS HIRED AND TRAINED TO GIVE THEIR OPINION ON THOSE PORTIONS OF THE SCORESHEET.

WHAT IF I DO NOT AGREE WITH THE SCORING SPECIALIST RULING?

THE SCORE REVIEW SPECIALISTS DECISION IS THE FINAL DECISION. IF YOU FEEL ADAMATLY THAT THEY ARE WRONG, YOU ARE WELCOME TO EMAIL CRAIG HALLMARK AT CRAIG@OPENCHAMPIONSHIPSERIES.COM AND HE WILL LOOK INTO IT AFTER THE EVENT CONCLUDES.

WHAT IF I DISAGREE WITH ANOTHER TEAMS SCORES?

THE ONLY SCORES THAT WILL BE DISCUSSED ABOUT OTHER TEAMS WILL BE THE DEDUCTIONS. WE HAVE OUR RED CARD CHALLENGE IN PLACE FOR THIS, AND THE GUIDELINES FOR THAT CAN BE FOUND ONLINE.

THE SCORE REVIEW SPECIALIST JOB IS TO REVIEW THE SCORES IF THE COACH DOES NOT AGREE WITH THE SCORES GIVEN FORM THE JUDGES ON THE PANEL.

IF DURING THIS REVIEW, ADDITIONAL THINGS ARE SEEN, THE TEAMS SCORE COULD BE RAISED OR LOWERED. YOU ARE NOT IN AGREEMENT WITH THE JUDGE THAT GAVE THE SCORE, SO YOU ARE ASKING FOR SPECIALIST TO REVIEW A VIDEO OF YOUR ROUTINE.

IF DURING THE REVIEW IT IS FOUND THAT YOUR TEAM IS UNDER SCORED, YOUR SCORE WILL BE CORRECTED AND YOU WILL GET AN UPDATED SCORESHEET.

IF DURING THE REVIEW, IT IS FOUND THAT YOU WERE GIVEN CREDIT FOR SOMETHING THAT SHOULD NOT HAVE BEEN GIVEN CREDIT, THE SCORE WILL BE CORRECTED AND YOU WILL GET AN UPDATED SCORESHEET.
