# HOW TO REGISTER

[CLICK HERE TO REGISTER!](#)

**Hint: Register for the Preliminary Round and Upgrade to an At-Large or Paid Bid During Your Season. Families are unable to book lodging packages until programs are registered!**

Step 1: Create a RegChamp Account with The Open. If you have an account with another event producer you can easily merge the information from that account into your Open account by using the same email address when you sign up.

Step 2 - Once you have entered RegChamp select "Events" on the home page.

Step 3 - Select "Go" next to your desired event (Allstar World Championship) and then hit "confirm."

Step 4 - Add your teams! If you have teams uploaded to your RegChamp account, select the teams you wish to register for the event from the "Import a Team" drop down menu and then click "IMPORT Team"

Step 5 - Select the correct division for your team and hit "Save." If you do not see your team's division, select "Check Division Criteria" to view the criteria for your desired division. On the next screen confirm your division selection is correct and hit "Done" If you do not have teams uploaded to your account yet, select the 3 stacked cubes on the left side of the screen labeled "Teams". Select "Create a New Team" and follow the prompts.

Step 6 - You are now able to view your invoice and you will follow the prompts to make your \$100 per team deposit.

**TEAMS MUST BE REGISTERED BY MARCH 11, 2026. AFTER THIS DATE, TEAMS CAN NO LONGER MAKE CHANGES TO THEIR ROSTERS AND MUST SUBMIT A ROSTER CHANGE REQUEST. TEAMS MAY STILL UPGRADE BIDS AFTER THIS DATE. TEAM PAYMENT DUE DATE IS MARCH 25, 2026. A \$250 PER TEAM FEE WILL BE ASSESSED FOR ANY ROSTER CHANGES AFTER MARCH 25, 2026.**

Your rosters need to include the following information, and be in excel format, in separate columns to upload.

- First and last name (separate columns)
- Gender
- Date of Birth
- Team ID (Found on Teams Tab on RegChamp)

Teams may still upgrade from the battle round to the preliminary round through March 25, 2026.

After March 25, 2026, teams may still earn bids and the credits associated with the subject bids, but teams cannot move from the battle round to the preliminary round.

## HOW TO ADD YOUR BIDS IN REGCHAMP

Once all bid-winning teams have been added to the event, you can add your bids in our registration system!

Step 1 - From your RegChamp account homepage, select the event, Click on "Docs, Reports, and Results".

Step 2 - Fill out the fields for: Company Awarding Bid, Bid Event, Bid Award, and Highest Bid Level

Step 3 - Click "Update"

Step 4 - Once received, our registration team will confirm the bid and approve/deny the bid

It may take up to 7-10 business days for bids to be approved in RegChamp.



# FREQUENTLY ASKED QUESTIONS

## TEAM REGISTRATION FAQS

### **QUESTION: DO I NEED TO MAKE A PAYMENT WHEN I REGISTER MY TEAMS IN REGCHAMP?**

YES! A \$100/TEAM DEPOSIT IS REQUIRED AT THE TIME OF REGISTRATION TO HOLD YOUR SPOT. ALL DEPOSITS ARE NON-REFUNDABLE. ALL TEAM CANCELLATIONS MUST BE SUBMITTED IN WRITING TWO (2) WEEKS PRIOR TO EVENT DATE ANY CANCELLATIONS MADE AFTER THE EVENT SPECIFIED FINAL PAYMENT DUE DATE ARE NON-REFUNDABLE. CANCELLATIONS WILL NOT BE ACCEPTED, PROCESSED, OR REFUNDED IF A CANCELLATION NOTIFICATION WAS NOT RECEIVED IN THE DESIGNATED TIME PERIOD. ANY TEAM NOT PAID IN FULL 24 HOURS PRIOR TO THE START DATE OF THE EVENT WILL NOT BE ALLOWED TO PARTICIPATE. NO EXCEPTIONS WILL BE MADE.
